The school is directed to ensure that :

1. The total number of section of the school after upgradation, shall be restricted to 18 (As per prescribed dimension) out of which, not more than 1/3rd sections may be used to run Senior Secondary classes and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2. 1. The number of sections shall be restricted to 18, of which no more than 1/3rd sections may be used for senior secondary classes. Any further increase shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of >500 ft dimension.
3. 2. The school has informed vide letter dated 17.04.2023 that order has been placed for installing lift and has enclosed copy of the work order. The school is required to install the lift and submit the compliance within 3 months on SARAS portal.
4. 3. The school has mentioned the land area as 8674 sq. mtrs. in the application whereas in the land certificate uploaded, the area is mentioned as 9928 sq. mtrs. The school has informed that there is a correction in the land area. The school is required to apply for correction in the land area on SARAS portal and submit compliance.
5. 4. The school needs to increase storage space and put proper seats in the maths lab. equipment is seen placed on tables along the wall and easy chairs are seen which are inappropriate. The school does not have permanent signage any where in the school. The school shall ensure proper permanent signage on all rooms and toilets, including CWSN toilets indicating the
